The 2015 Southern California Tour

California's historic drought is drawing attention to the responses in different regions of the Golden State. Inland Southern California, an area both rich in agriculture and dense with urban populations, employs a number of innovative strategies to manage groundwater, drought-proof communities and recycle water so that each drop is used efficiently.

The two-day tour spans the western areas of San Bernardino and Riverside Counties and will have great value to water resource industry staff, finance industry professionals, engineering firm personnel, legislators and their staff, members of the media, academics, local government officials, advocates, stakeholders, environmentalists and public interest organizations. **The tour is co-sponsored by Riverside County Flood Control District, CV Strategies, CH2M Hill** and **ESA**.
